16.0 Committee Impact Reports

16.1. Nominations and Governance Committee (Paper N)

- 16.1.1. The Nominations and Governance Committee had begun its search for new members of Council with financial and audit experience and an interview panel had seen four candidates, with one further interview to be arranged.
- 16.1.2. With regard to staff members of committees, because of changes in the faculty and school structures, the Nominations and Governance Committee had agreed to recommend to Council for approval, that all committee members should have their terms extended, even if they had already served two years. The elections would be held after the new structure had been implemented.
- 16.1.3. The committee had been presented with a number of different options in which the Charter could be re-written and taken out of the oversight of the Privy Council, and it had taken a good deal of conversation to agree a consensus. This would be brought back to Council in due course.
- 16.1.4. A governance review would be undertaken with a view to improving effective engagement between Council and stakeholders, the effectiveness of the committees, and a review of academic governance in line with the re-organisation of academic services.
- 16.1.5. Finally, there would be a production of a Scheme of Delegation showing not only decision making, but about what activity would take place at all levels across departments and would make responsibilities of roles much clearer.
- 16.1.6. Council approved that all committee members should have their terms of office extended, even if they had already served two years.
